## Installation Guidelines for **Perlato Stone** also known as **White Linen**:

## Guidelines for Wet laid on a Concrete Slab:

- 1.) Compacted Sub-Grade to minimum bearing compacity of 2 tons/SF.
- 2.) 4" -6" Compacted ¾" Clean Gravel Base. Compacted in 3" Lifts using a minimum of a 7,000 lb. plate compactor.
- 3.) 4" 6" Reinforced 4,000 PSI Concrete Slab. Slab to be reinforced with #3 bars 12" on center /both ways.
- 4.) Concrete Slab to be poured within 3/8" of grade with a 2% slope = 1/4" / Ft. Surface must be troweled smooth and the slab must be allowed to cure for 28 days prior to installation of pavers.
- 5.) Expansion joints to be installed every 10' on center /both ways. Where the slab abuts all new or existing permanent structures (example: house foundation, pool, retaining walls, steps, treads etc.) must have a **Soft Joints**. Recommended **ARDEX SX Caulk** \* for Soft Joints and use backer rod if necessary.
- 6.) A.) Install Perlato / White Linen stone using **ARDEX Thin Set Mortar** X-90 up to a maximum thickness of 5/8" or X-32 up to a maximum thickness of 11/4". Use a ½" notched trowel to spread thin set to the slab and back butter each piece. Set in place with a rubber mallet to eliminate any voids and insure a proper bond. Mix and Install per manufactures instructions.
- 7.) A.) Use ARDEX FH or FL polymer fortified grout for grouting once setting bed material if fully dried. Allow grout to dry 12-16 hours. Mix and apply to manufactures specifications.

\*\*Sealing the stone is an option but not required or necessary.

\*Note: Silicone caulk substitutes could possibly stain the surface.
